1. About SBI Payments:

SBI Payment Service Private Limited (hereinafter referred to as "SBI PAYMENTS") is a Joint Venture between SBI & Hitachi Payment Services, established with the objective of carrying out Merchant Acquiring Business activities.

2. Invitation of RFQ

SBI Payments seeks proposals from qualified firms for supply and installation of servers and implementation support for configuration of software licenses per the scope of work section.

3. Eligibility Criteria

- The vendor should have at least 2 years of experience in supplying/providing similar product/services. Bidder needs to provide Purchase Orders / Work completion certificates.
- The vendor should have a valid PAN, GST registration.
- Manufacturer Authentication Certificate from the OEM shall be submitted along with the technical proposal.
- Participation to this RFQ is allowed to OEM / OEM Authorised Channel Partner / Resellers as per minimum technical specifications prescribed in this RFQ. Mentioned specifications are bare minimum required by SBI Payments and not exhaustive. The bidders are expected to propose suitable product / solution accordingly.

4. Scope of Work:

4.1. Supply, installation and configuration of all the required Server and Software at SBI Payments site - 95, Ganpatrao Kadam Road, Opp. Peninsula Business Park, Lower Parel, Mumbai-400013. The Complete setup shall be configured ready to use / operate by SBI Payments users.

- 4.2. Server Warranty up to 05 years (mandatory) on-site comprehensive warranty covering all parts and labour from the date of acceptance of the systems by SBI Payments.
- 4.3. The detailed Product Specifications / Bill of Material along with Make, Model number and quantity shall be submitted with the technical bid.
- 4.4. The successful bidder expected to provide all necessary back-to-back support from OEM for delivery and installation of the Servers & Software, warranty and required support during the warranty period.
- 4.5. Manufacturer's authorisation form shall be provided for the hardware offered by the bidder.
- 4.6. All the products proposed / supplied by the bidder shall be compatible with the latest version of Operating System.
- 4.7. Bidder shall supply only those products, which would not be declared end of life until March 31, 2030. Further, the proposed products should also not go End of Support before March 31, 2030. However, in cases where the OEM decides to phase out any particular model, the vendor is required to substitute (upgrade) the product with another product. The bidder must inform well in advance about such changes. In case no substitute model is available, the OEM

6. SLA and penalty terms:

6.1. Service level Requirements

The Bidder is expected to take care of the systems by covering them under the contract period which in line with the OEM back-to-back support to meet the SLA commitments as below:

Any issue could be classified under the following four categories

- Level 1: The identified issue has a material business impact (Show Stopper)
 and needs to be resolved immediately. This level would typically correspond
 to issues that result into disruption of Solution services to SBI Payments. It is
 expected that the Bidder provides an immediate solution/ work around.
- Level 2: The identified issue has a significant business impact and needs to be taken up on top priority. This level would typically correspond to issues

that result into disruption of one or more critical services to all the SBI Payments.

- Level 3: The identified issue has normal impact on the Business and needs
 to be addressed at the earliest. This level would typically correspond to issues
 which result into disruption of one or more services to one or more but not all
 SBI Payments.
- Level 4: The identified issue has almost no impact in terms of Business.
 However, issue needs the attention of the Bidder and shall be fixed on lesser priority.

6.2. Penalty:

The inability of the Bidder to provide the requirements as per the scope or to meet the deadlines as specified would be treated as breach of contract and invoke the Penalty Clause. The maximum limit on the penalties during the period of contract shall be 10% of the total contract value. The applicable "Penalties" would be the same irrespective of the root causes.

7. Other Terms & Conditions:

- 7.1. Validity of quotation: Bids should remain valid for the period of at-least 90 days from submission date.
- 7.2. Method of selection of successful bidder: Based on Least Cost System (LCS).
- 7.3. Delivery Terms Within 4 weeks from the date of PO issuance.
- 7.4. Payment Terms 100% against completion of supply, installation and configuration of server.
- 7.5. Liquidated damage In case of delay by the Bidder in any stage of the project milestone, the financial Penalty as per the SBI Payments discretion will be imposed on the Bidder @ 2.5% of the total contract value per week of delay, to the maximum of 10% of the total contract value.
- 7.6. Performance Bank guarantee The successful Bidder shall provide a Performance Bank Guarantee of 10% of the Total Cost of ownership for a period of 05 year.
